1. Exhibit B in the Master Deed, as amended and restated by the First Amendment, is hereby amended and restated as set forth on the revised **Exhibit B** attached hereto and all references to Exhibit B in the Master deed and first Amendment shall mean the revised Exhibit B attached hereto.

2. Exhibit A to the Second Amendment is deleted in its entirety.

3. Except to the extent expressly amended or modified hereby, all other provisions of the Master Deed and its subsequent amendments shall remain in full force and effect.

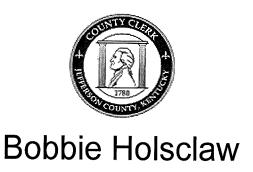
